of Studies (Economics) and requested for a continuation of the same syllabus, which was approved by the Council members. She also presented the draft TYBCom Business Economics syllabus as prepared and approved by the Board. Mr. Santosh U Patil and Mr. Bhushan Marde were granted leave of absence.

The Member Secretary welcomed all the honorable members of the Academic Council of R. A. Podar College of Commerce and Economics (Autonomous). The agenda of the academic council meeting was read out. With the permission of the Chairperson the meeting commenced.

**Item 1. To read and confirm the minutes of the Academic Council meeting held on Monday, 25th October 2021**

The minutes of the meeting held on 25th October 2021 was emailed to all the honorable members which were duly confirmed.

**Item 2. To discuss and pass the Arrangement of Terms for the academic year 2022-23.**

The member secretary told all that the college would reopen on 13th June 2022 as per the guidelines of the University of Mumbai. The academic calendar as prescribed by the University of Mumbai would be followed by R.A.Podar College.

**Item 3. To discuss the conduct of evaluation of the learners and the declaration of results of the academic year 2021-22.**

The result of the odd semester of 2021-22 was shared by the Controller of Examination with all the members. She informed all members about the smooth conduct of semester examinations in online and offline mode for the year 2021-2022. She also informed the honorable members the result processing is on and the result shall be declared within the stipulated time. She informed the members that the Sem II examination was conducted offline as per the University of Mumbai guidelines. She placed before the members for framing the rules for moderation for offline examination. The proposed moderation rules is as follows :

“5% of Students failing by 10% of aggregate Marks of that paper (18-23 marks for 60 marks paper) would be moderated.5% of Students securing 60% & above of aggregate marks of that paper(36 & above marks for a 60 mark paper) would be moderated and 5% of Students securing between 24-35 marks( for a 60 mark paper) would be moderated. If the marks decrease by less than 25% in 30% of answer books moderated then a re-assessment of all the answer books in the bundle shall be undertaken.” The moderation rules suggested by the Controller of Examination was approved unanimously.

She also spoke about the Grading pattern. She asked for permission to continue with the grading pattern during admission time till the learner graduates from R. A. Podar College of Commerce and Economics (Autonomous).The Operational aspects with respect to examination and declaration of results shall remain the same as it was in practice at the time of admission and the academic year relevant to the same. It was approved by the honorable members.

**Item 4. To pass and approve with or without modifications F.Y.B.Com /F.Y.B.M.S Syllabus.**

The honorable members approved the minor changes made in the syllabi of F.Y.B.Com and F.Y.B.M.S. It was informed that no changes have been made in the syllabi of SYBCOM, TYBCom, SYBMS, TYBMS , MCOM part I and II

**Item 5. To pass and approve with or without modifications F.Y./S.Y./TY BCom in Actuarial Studies syllabus.**

The revised Syllabi of B.Com. with Actuarial Studies from Semester I to Semester VI was presented before the honorable members. While introducing the modifications the Chairman of Academic Council briefed the members about the need for revision. She shared the possibility of a collaborative arrangement with the Society of Actuaries, USA and Faculty of Actuaries, UK. She informed the honorable members that the dialogue between the two international organization necessitated the mapping of the courses to be cleared under SOA and IFoA with the courses offered in the actuarial studies course of R.A. Podar College. This revised syllabi would enable the learner from Podar to get few benefits if they appear for the examination conducted by SOA and IFoA. The final modalities of the benefit shall be worked out if the Academic Council give approval for this revision. Responding to this information, all the honorable members of the Academic Council expressed their approval and appreciated the efforts put in by the College. Mr. Ashok Pradhan, Senior member of the Academic Council made an observation that the college is using the academic autonomy given to them by the UGC and University of Mumbai in the most appropriate manner. He also proposed a motion of appreciation for the Podar faculty which was unanimously approved by all the honorable members.

**Item 6. To consider and pass with or without modification the syllabi of New Undergraduate and New Post Graduate programs to be introduced in R. A. Podar College.**

The Chairman of Board of Studies for Self Financing Programme, Vice Principal Kavita Jajoo presented her view about the need for commencing innovative employment oriented new Undergraduate and Postgraduate Programs. She explained the changing environment and the emerging job opportunities and the need for providing new skill sets to the learners at R.A.Podar College. She also explained the brain storming session which resulted in the proposal of the following UG and PG programmes. She also presented the syllabi for Semester I and Semester II for the proposed new programs. The programs proposed are

The four credits earned by the Podar learners as a mandatory credit course namely Life Enrichment Course and Responsible Citizenship Course was appreciated by all the honorable members of the Academic Council. The members appreciated the efforts by the institution and congratulated the Principal and the faculty members.

**Item 2. To appraise the honorable members about NEP 2020 credit structure and implementation plan.**

The Chairperson of the Academic Council, Dr Shobana Vasudevan, shared with all honorable members of the implementation plan of NEP 2020 at Podar College. She asked the member secretary to share the credit structure of all UG and PG programs. She said they were planned keeping in mind the framework of NEP 2020 guidelines. All honorable members unanimously approved the credit Structure.

**.Item 3. To discuss the examination held and results declared of the learners in the even semester of Academic year 2022-23.**

Prof Vinita Pimpale, the COE of Podar, talked about the post covid performance of students in Mumbai and comparatively excellent results at Podar in the academic year 2022-23.

**Item 4. To discuss the conduct of evaluation of the odd semester of the academic year 2023-24.**

The COE briefed members of the credits , evaluation system and new Grading system which will be followed from 2023-24. Outside students (Non autonomous or other autonomous colleges) who take admission in the second or the third year the results will be mapped as per RAPCCE grading system and a remark to be put up on the mark sheet as RAPCCE grading system.If a learner wishes to exit after SEM II , a learner will have to complete Tally Course (2 credits) and Entrepreneur Development Course ( 2 Credits).

It is suggested to form an equivalent committee to find out the equivalent for the student from the non-autonomous and non-NEP program to Podar College (Autonomous), the university does have eligibility but at college level a five-member committee could be set for equivalence purpose. More than 3000 students have registered on the ABC portal. Supplementary examinations will be conducted prior to regular semester examinations. An additional Supplementary examination will be conducted in the month of June.

She later asked for permission to start an Equivalence Committee to enable learners to move from one institution to another. From autonomous to non autonomous
