We believe that the college library has been the resource center for students, teachers and researchers. It plays vital role in teaching, learning, and research. Nowadays it's an age of information technology which has transformed the packaging, processing, storing and dissemination of information. It has made a great influence on information seeking pattern of students and teachers. Every user wants information on a click of a button. No library can afford to lag behind in such a rapidly changing educational environment.

To cope with changing demand and quick access to the information sources, Podar College library no longer restricts itself from acquiring print materials but has extended its efforts to bring in cybernetic set up to provide access to its readers by subscribing to the major online databases and online peer reviewed journals. It has created metadata of its holdings, and have been offering online reference services. College library has already started digitization of inhouse materials such as question papers, research articles of faculty members and newspaper clipping, etc. Readers can access the database through college website http://rapodar.ac.in/library.php under the heading 'Podar Digital Archive'.

New additions to library Collection: This year, college library added 620 books, subscribed to 59 (National and International) Journals and 04 online databases. Library also renewed subscription to INFLIBNET's NLIST to support research in the college.

Library Services: Along with Book Bank facility, College library also renders other services like Home reading, Reference, Documentation, Photocopying, Bibliography, Inter-Library Loan, Current Awareness Service and Internet surfing. Library also conducted training for teachers and students for hands on Practice on online Databases, e-Journals, Online Public Access Catalogue etc.

Computerized Library: The library has been using the SLIM21 library software for more than 18 years. The library is fully computerized with all major modules namely Acquisition, Cataloguing, Circulation, and Serial Control. OPAC (Online Public Access Catalogue). OPAC is available online. Almost all transactions are made through computerized programs. We renewed the AMC for internet facility and the speed was also upgraded this year.

Book Bank Scheme of University of Mumbai: This year college library has given 60 sets of books to the students who hail from the economically weaker section of the society. The set of books are given under the University of Mumbai Book bank Scheme and College Book Bank scheme.
