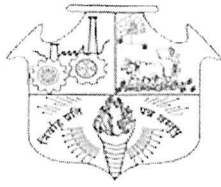

## 2. About the Institution

R. A. Podar College of Commerce and Economics (Autonomous) is one of the leading and premier educational institutions in the stream of commerce in Mumbai city run under the flagship of the Shikshana Prasarak Mandali, Pune. The College is the first non-government Commerce college to be started by the University of Bombay, in January 1941. The college was granted permanent affiliation by the then University of Bombay, on 17th August 1950. The College is accredited by NAAC with an A+ grade and a CGPA of 3.68, in the third cycle on 22<sup>nd</sup> February 2017. (Valid until 21<sup>st</sup> February, 2024).

A single-faculty Commerce College, it offers six UG Programs - B. Com with Accountancy and Business Management, Bachelor in Management Studies, B.Com in Actuarial Studies, B.Com in Financial Markets, BBA in Shipping and Logistic Management and BSc in Data Science and Analytics. It also offers 5 PG programmes- M.Com - in Accountancy, M.Com - in Management, M.Com - in Business Analytics, M.Com - in Behavioral Finance, M.Com - in International Business and four Ph.D. programmes.

- Orienting learners about new programs




## **5. Guidelines, Suggestions and Recommendations for improvement**
